I. COURSE DESCRIPTION

A study of Acts examines the birth and growth of the early church. In addition to studying the historical sequence of events, you will consider Luke's theological themes, learn to extrapolate biblical principles from historical narrative, and apply those principles in the development of contemporary missions strategy. Attention will be given to the use of Acts for teaching and preaching.

III. COURSE OBJECTIVES

A. General Objective

- 1. To learn the sequence of events in the growth of the early church as presented in Acts.
- 2. To understand Luke's theological interests and purposes in writing Acts.
- To develop an ability to legitimately extrapolate principles from historical narrative and apply them in the development of contemporary missions strategy.

B. Specific Objectives

- 1. To be able to handle Acts as a witness to first century history. To understand the sequence of events presented in Acts.
- To understand the growth of the early church within the context of first century history. To be able to study historical background of details of Acts. To be able to handle historical-critical matters concerning the text's accuracy.
- 3. To identify and understand aspects of Luke's theology of church and mission.
- 4. To see the parallels and contrasts between the first and twentieth century missionary situations and develop ability in applying the Biblical principles, illustrated in Acts, to contemporary missions strategy.

IV. COURSE REQUIREMENTS

- A. Lectures Viewed: View and take notes on all video introductions, narrated Explanations, and narrated PowerPoint lectures listed on the Assignment Schedule. The narrated Explanations explain course assignments. The lectures will aid in notebook preparation and are part of the database for the exams. A Study Guide supporting the narrated PowerPoint lectures is posted at the course website.
- B. Internet Interaction (20%): For course interaction, you will be required to engage in Internet Interaction by making and responding to individual postings on the course website particular Discussion Forum portals and participating in live Chats. Instructions for each forum are at the particular forum portal on the course website. There are ten items (2 pts each) indicated on the Assignment Schedule.

This area is graded quantitatively vs. qualitatively. In other words, the student receives a standard "95" for posting a forum topic and responding to two class members. He also receives "95" for participating in a chat or, if absent, reading the chat transcript afterward and sending the instructor an email with answers to the chat questions and observations. The instructor will post an omnibus response to each forum topic discussion and will guide each chat. In order to account for any late postings, the instructor will scan through each forum discussion topic one last time on the MON of the last week of the course.

C. Historical Analysis Notebook (8%):

- 1. Text and Commentary Reading (3%): Read the assigned chapters in the book of Acts and the appropriate commentary sections for the assigned number of hours. Along the way, note down important historical critical problems and/or historical background details. Fill out the "Acts and Commentary Reading" Checklist and include it with the Historical Analysis Notebook.
- 2. Historical Background Study (2.5%)
 - a. Choose **one** historical/cultural detail from Acts 1:1-15:35 and **one** from Acts 15:36--28:31 on which to do background study. As you choose, consider studying a historical background detail, which is related to the theological analysis, and mission strategy paper topics you are pursuing.
 - b. Identify through Larkin Commentary or other commentaries on reserve (ask CIU circulation librarian [kflickner@ciu.edu] for scanned pages) an ancient source reference that will provide background evidence for your detail (e.g., OT; Jewish writings-Philo, Josephus; Greek and Latin writers; non-literary evidence such as papyri, inscriptions). See "Exegetical Method for English Bible Students" posted at the course website for orientation on ancient documents.
 - c. Look up that ancient reference, read the context, and think about how this reference helps you understand your historical/cultural detail better (use www.perseus.tufts.edu for

- English texts of key ancient sources).
- d. Note down the exact reference to the ancient document and enough of the immediate context so that at a later time you will be able to recall the content.
- e. *Explain* how the background helps you better understand the detail in your passage.
- 3. Historical-Critical Evaluation (2.5%)
 - a. With the aid of the Larkin *Commentary* and Barrett, Johnson, and Pervo (ask CIU circulation librarian [kflickner@ciu.edu] for scanned pages) *identify* **one** detail from Acts 1:1-15:35 and **one** from Acts 15:36--28:31 which scholars using the historical-critical method have concluded are either historically inaccurate or inauthentic (did not happen in history).
 - b. *List*, as identified by Larkin et al, the historical critical objections to the report either in terms of its accuracy in presenting the detail or the authenticity of the detail itself.
 - c. Answer each objection with the aid of Larkin and Witherington (ask circulation librarian [kflickner@ciu.edu] for scanned pages).
- D. Theological Analysis Notebook (12%): Do A Theological Theme Study on two concepts in the Book of Acts: "growth" and "turn," based on the Greek vocabulary, by doing the following steps:
 - 1. Meanings Identification:
 - a. Collect with the aid of Internet resource: www.blueletterbible.org
 the occurrences of the following words in Acts, beginning with their first occurrence as identified by passage and English translation term below:
 - "growth" (Greek vocabulary auxanó [au)ca/nw] "increase,"
 Acts 6:7; pléthynó [plhqu/nw] "multiply," Acts 6:7). In your
 evaluation put together one profile of the "growth" concept in
 Acts.
 - "turn" (Greek vocabulary épistrephó[e)pistre/fw], "to convert," Acts 3:19; 11 total occurrences)

Protocol for Internet aided Search: at www.blueletterbible.org use this protocol: click on search in left menu - verse retrieval, enter passage and check "Show Strong's numbers". Click on Strong's number (to the right of the word you desire to search). A Lexicon Results page will appear with definitions and all the books in either the Old (Hebrew) or New (Greek) Testament in which the word occurs. Click on the Bible Book in the Right hand Column (i.e., Acts) and all the occurrences in Acts will appear.

b. *Group/Classify* all the occurrences of the word in Acts according to meanings indicated by each context.

- "Lexical Meaning": Begin with the skeletal outline of the categories of use of the term as given in lexica/dictionaries. Use "Outline of Biblical Usage" or "Thayer Lexicon" on the Blueletter Bible Lexicon Results page. Or, consult Bauer Danker³ (electronic reserve).
- "Contextual Meaning": Fill out the outline with subcategories that are aspects of usage in context. Clues from "contextual meaning" for sub- categories of grouping/ classification are: for verbs--the subjects and objects used with them; for nouns--the verbs and modifiers used with them. The categories taken as a whole comprise the word's range of meaning.
- c. Record enough of the *immediate context* in noting down each occurrence so that you can readily identify the term's meaning at that place.
- 2. **Theological Evaluation**: *Identify and label*, using the suggested symbols, those occurrences which are theologically significant because they meet one of the following criteria and promote Luke's purpose for writing Luke-Acts.
 - T/P--Occurs in <u>Christian teaching</u> or <u>preaching</u> sections or <u>speeches</u> in which the truth is being told
 - Narr--Occurs in <u>positive statements</u> indicating the narrator's, i.e. the author's, approval
 - PL--Its place in the <u>immediate context</u> or <u>book</u>
 as a <u>whole</u> indicates its importance for the writer
 and also its normative status.
 - (Is part of theological teaching elsewhere in Luke-Acts, especially in the teaching of Jesus in the Gospel of Luke.)

3. **Synthesis**

- Describe in a concise, yet comprehensive, statement the theological content of the word in terms of its range of meaning.
- b. *Comment* on Luke's emphases as indicated by frequency and placement.
- State briefly how the theological content of this word promotes Luke's theological purposes in writing Luke-Acts.
- E. Theological Analysis Paper (16%): Write a paper (5-7 pp; est. workload, 21 hrs. ea.) on the assigned topic: *Approach to Other Religions*: Luke's View of the Relationship between Natural Revelation and Non-Christian Religions (Acts 14:11-18; 17:22-31). Use the following steps:

- 1. *Consultation with Instructor:* "Skype" the instructor to find out what is at issue in your topic and how to research it.
- 2. Collection of Bibliography: Identify a bibliography of 5-7 items (including three commentaries and one journal article or book essay) in support of your topic by looking into the following areas:
 - Jumpstart Provision Posted at the course website as Reserve Readings are a) Article and essays noted in the bibliography in support of the paper topic; b) Student papers from prior iterations of the course.
 - Database Indices Search A) ATLA database in the CIU Library databases is available online through "Helpful Links/Library" at the course website home page. Search under subject or Scripture Citation Bible Book chapter and verse. B) New Testament Abstracts database in the CIU Library databases. Again access online through "Helpful Links/Library" at the course website home page.
- 3. *Preliminary Study of the Topic*: Read one or two items from your bibliography, which can orient you to your topic.
- Primary Research: Do your own study of Theological Analysis of the topic.
 This will include theological theme studies (3-5 words, which include use in both Luke and Acts) and exegetical study of passages germane to your topic. Draw preliminary conclusions.
- 5. Secondary Research: Study other scholars' contributions on your topic. This will provide additional background, evidence, insight, and challenge or support for your preliminary conclusions. When using works on library reserve, ask CIU circulation librarian (kflickner@ciu.edu) for scanned pages.
- 6. Writing Up:
 - a. Write a detailed outline of the paper and then the paper itself. Be sure you identify what is at issue, a thesis statement, marshal your evidence (e.g., material from theological theme studies) and argue effectively through to your conclusions.
 - b. In form and content, the paper should contain correct spelling, clarity of thought, and felicity of style. It should contain the title at the top of the first page of the text; abbreviated primary and secondary references, which may be cited in parentheses in the text of the paper; and a full bibliography of the works actually cited. The SSM Style Sheet is the standard;
 - c. At least two articles from a journal and/or a volume of essays must be consulted and included in the bibliography.

- F. *Mission Strategy Analysis Notebook* (10%). Do Mission Strategy Analysis using the following steps:
 - 1. **Reading and Summary**: Read the assigned reading and in a few sentences summarize its main point(s).
 - 2. **Evaluation**: Answer the following questions citing one example with reasons to substantiate each reply.
 - a. Was the use of Scripture faithful to the New Testament writer's purpose and theology?
 - b. Has the writer taken into account the differences between the first and twentieth century historical and cultural contexts in his framing of biblical principles for mission strategy?
 - c. Was the application of the principles both practically helpful and faithful to the authoritative content of Scripture?
 - 3. **Overall Evaluation**: Were the article's point(s) faithful to Scripture? Answer with reasons.
- G. Mission Strategy Analysis Paper (16%): Write a paper (5-7 pp; est. workload, 21 hrs. ea.) on the assigned topic, Approach to Other Religions: Principles, Strategy, and Tactics for Approaching Non-Christian Religions African Traditional Religions, a case study using the following steps:
 - 1. *Consultation with Instructor*: "Skype" the instructor and find out what is at issue in your topic and how to research it.
 - 2. Collection of Bibliography: Identify a bibliography of 5-7 items (including three commentaries and one journal article or book essay) in support of your topic by looking into the following areas--
 - Jumpstart Provision- Posted at the course website as Reserve Readings are a) Articles and essays noted in the bibliography in support of the paper topic; b) Student papers from prior iterations of the course.
 - Bibliographical Search a) Contemporary Cultural Context: ATLA database (see below). b) Biblical Principles (Use your theological analysis paper): c) Mission Strategy and Tactics: 1] ATLA database in the CIU Library databases is available online through "Helpful Links/Library" at the course website home page. Search under subject area;.

As you have access to print resources, the following are especially helpful for missions resources: 1] Bibliographies BInternational Review of Missions Bits bibliography; Missionalia - its bibliographical abstracts; Theology in Context - bibliography; 2] Tables of contents of the relevant mission periodicals (see Missions Periodicals list below). Most helpful will be Evangelical Missions Quarterly, Evangelical Review of Theology, International Bulletin of Missionary Research, International Journal of Frontier Missions, International Review of Missions, Missiology.

3. *Preliminary Study of the Topic*: Read one or two items from your bibliography, which can orient you on your topic.

- 4. Primary Research: Do your own mission strategy analysis.
 - a. Describe the Contemporary Cultural Context for which you will do mission strategy.
 - b. What Biblical principles relating to your topic may be propounded from Luke's theology? The student should use his theological analysis paper and papers from prior years posted on electronic reserve on the course website.
 - c. Frame the Biblical principles into points of strategy, having regard for the differences between the first and twentieth century historical and cultural contexts.
 - d. Make practical, specific applications of the points of strategy to the current situation in the form of tactics.
- 5. Secondary Research: Study other scholar's contributions on your topic. This will provide additional background, evidence, insight, and challenge or support for your preliminary conclusions. When using items on Library Reserve, ask CIU circulation librarian (kflickner@ciu.edu) for scanned pages.
- 6. Writing Up:
 - Write a detailed outline of the paper and then the paper itself.
 Organize the paper according to the study process under #4 above.
 - b. In form and content, the paper should contain correct spelling, clarity of thought, and felicity of style. It should contain the title at the top of the first page of the text; abbreviated primary and secondary references, which may be cited in parentheses in the text of the paper; and a full bibliography of the works actually cited. The SSM Style Sheet is the standard;
 - c. At least one article from a journal and/or a volume of essays must be consulted and included in the bibliography.
- H. *Examinations*: Take two period exams, and a final exam based on the self-study preparation material, the assigned readings, and the material covered in Narrated PPT Lectures. (5%, 5%, 8%)
- I. Assignment Due Dates: All specific term due dates for written and Internet interaction assignments are contained in the Assignment Schedule posted on the course website.
- J. Assignment Submission Policy: Assignments submitted electronically must be in Word (.doc) or Adobe Portable Document (.pdf) format. Remember to copy and save onto your hard drive and then submit a copy electronically to the course website. Please do this with all assignments that are submitted.
